Minutes of the Parish Council Meeting held on Thursday 16 June 2005 at 7.30 pm in the Memorial Hall, Burton-in-Kendal

1. APOLOGIES FOR ABSENCE: Cllrs. F.Mason-Hornby, P.Rogers

2. MINUTES OF THE MEETING held on 19 May, having been previously circulated, were confirmed as correct and signed by the Chairman after the word 'record' was inserted between 'correct' & 'and' on Item 5, plus a comma was inserted between 'thefts' & 'and' on item 7.1, plus the word 'which' was inserted between 'Burton' & 'stated' on item 7.2 and the word 'earmarked' was enclosed with inverted commas.

3. CHAIRMAN'S ANNOUNCEMENTS (Action by)

- The Standards Board have decided the allegation against T.Jolley of using the work of the Parish Council for political gain should not be investigated.
- Request from SLDC to update registrations of Cllrs. financial interests was actioned.

- Councillors have has received complaints about the security shuttering and the neglected state of the Royal Hotel. The Chairman has been given to understand this will be attended to when a new tenant has been installed.
- Drains at the bottom of Boon Town are blocked **(CD)**
- Cllr.R.Boddy presented a Recreation Trust report on the drainage problem. This was put into the Circulation File. It was agreed further investigations are required when it is raining **(GI)**
He also requested a 15 mph speed limit on Clawthorpe Lane **(CD)**
- Cllr.G.Isherwood requested an extension to the white lines on the road junction outside the school and a parking space marked for one disabled vehicle. He agreed to provide the Clerk with a plan **(GI)**
- Cllr.J.Hopwood reported that the bid to the Countryside Agency had been submitted. The panel meets on 19 July.

- **Suggestions:** Although I agree wholeheartedly that there is a need for affordable housing, I would be saddened to see The Royal used for this. It's a prime site in the centre of the village and I would far rather see it used for business and/or recreational purposes. It may be that 2 pubs are not sustainable in the village on drinks sale alone, but there surely is a need for accommodation and good food places to which visitors could be enticed? What about using the site for other business/leisure use instead of as a pub? (No I don't mean as a supermarket or anything so massive!) Bringing in custom from outside the parish must be good for village businesses and will help to ensure Burton remains a lively vibrant living community and doesn't become just a dormitory area for commuters elsewhere. Identifying pockets of land where a small number of houses may be built is important, but this needs to be done without damaging the commercial side of village life. In my view it's a matter of getting the balance right between housing and commercial activity to keep the village healthy - people need homes AND places to work and spend their leisure time.
- Noticed a comment in the editorial of the June issue of Burton News concerning Dog Mess and wondered if the provision of more poop scoop bins in and around the village would encourage people to clean up after their dogs. An ideal place would be at the bottom of the steps onto the canal at Burton Wharf or by the bench at the side of the motorway bridge on Station Lane.
